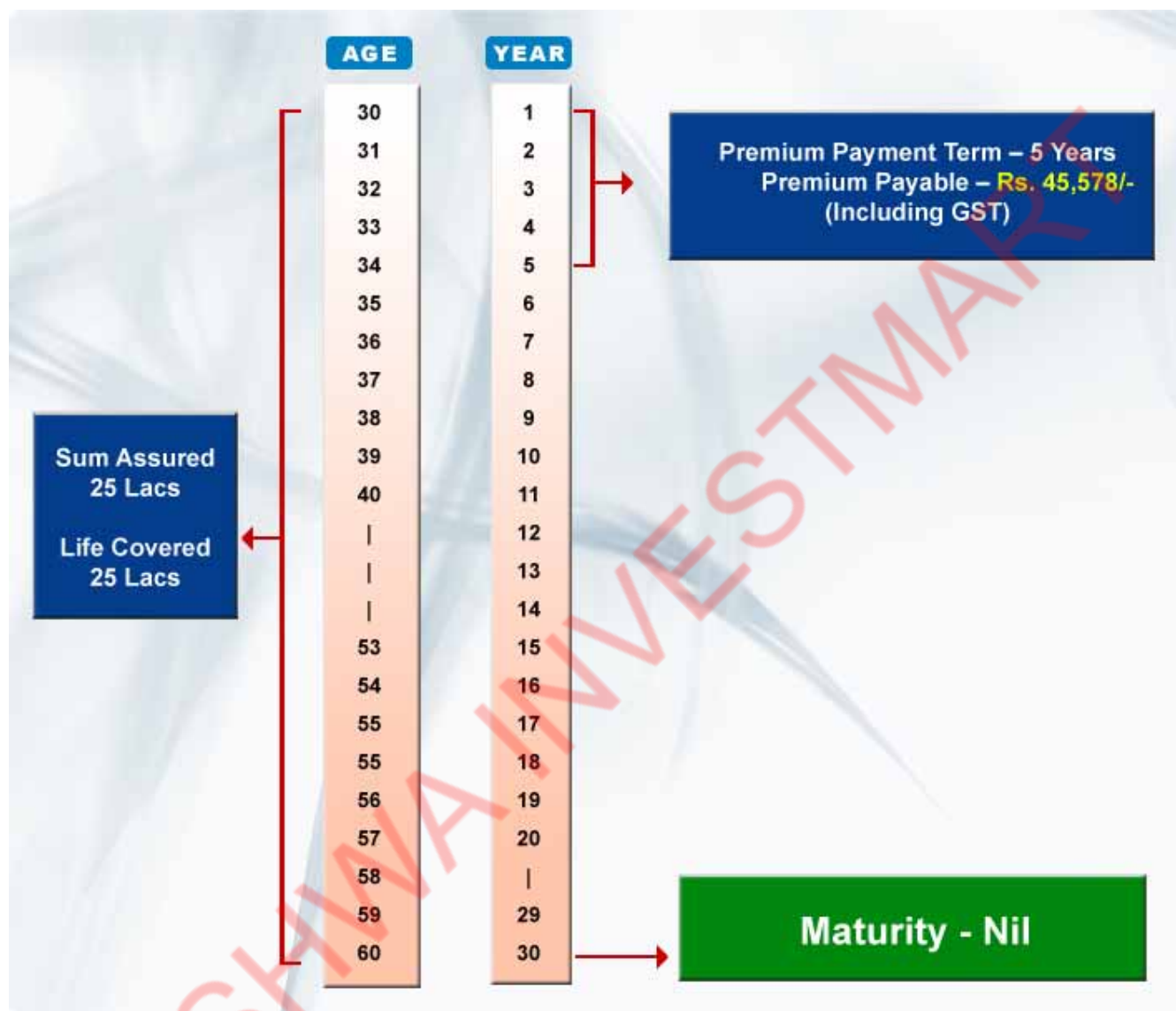
Plan Benefits
